Todd talked about the wildfires he was on with Nick E and Nelson. The Waconda Fire (Union Ne) they were given \$1,848 plus fuel. The Broken Bow fire brought in \$2,945. The total of \$4,793 for both calls.

The department needs to get Nick E and Nelson true wildland gear if they are to continue going to these fires.

Nate made a motion to spend ½ the money brought in on equipment and gear needed. Also to pay Nelson \$150 a day for when he goes on these fires because he uses vacation time to attend the wildfires. Nick L 2nd

At the mutual aid meeting we may be asking for each department to donate money for an ATV. They are helpful for wildfires.

Todd is doing research on High Viz cameras and would like us to consider purchasing one in the future. Approx \$2500

Nate made a motion to put the Samsara camera on Unit 41 and 22. It costs \$33 a month for each unit. Matt seconded it.

Nate is looking into the digital radios for trunkable radios for 99-1 and Unit 41. Eventually this will be the radios used. Grants were discussed.

Nick E suggested using Pulsepoint app to get the information on fire calls needed to fill out reports for the Nebraska Forestry.

Urby is going to have August training at his place this summer. Date TBD
